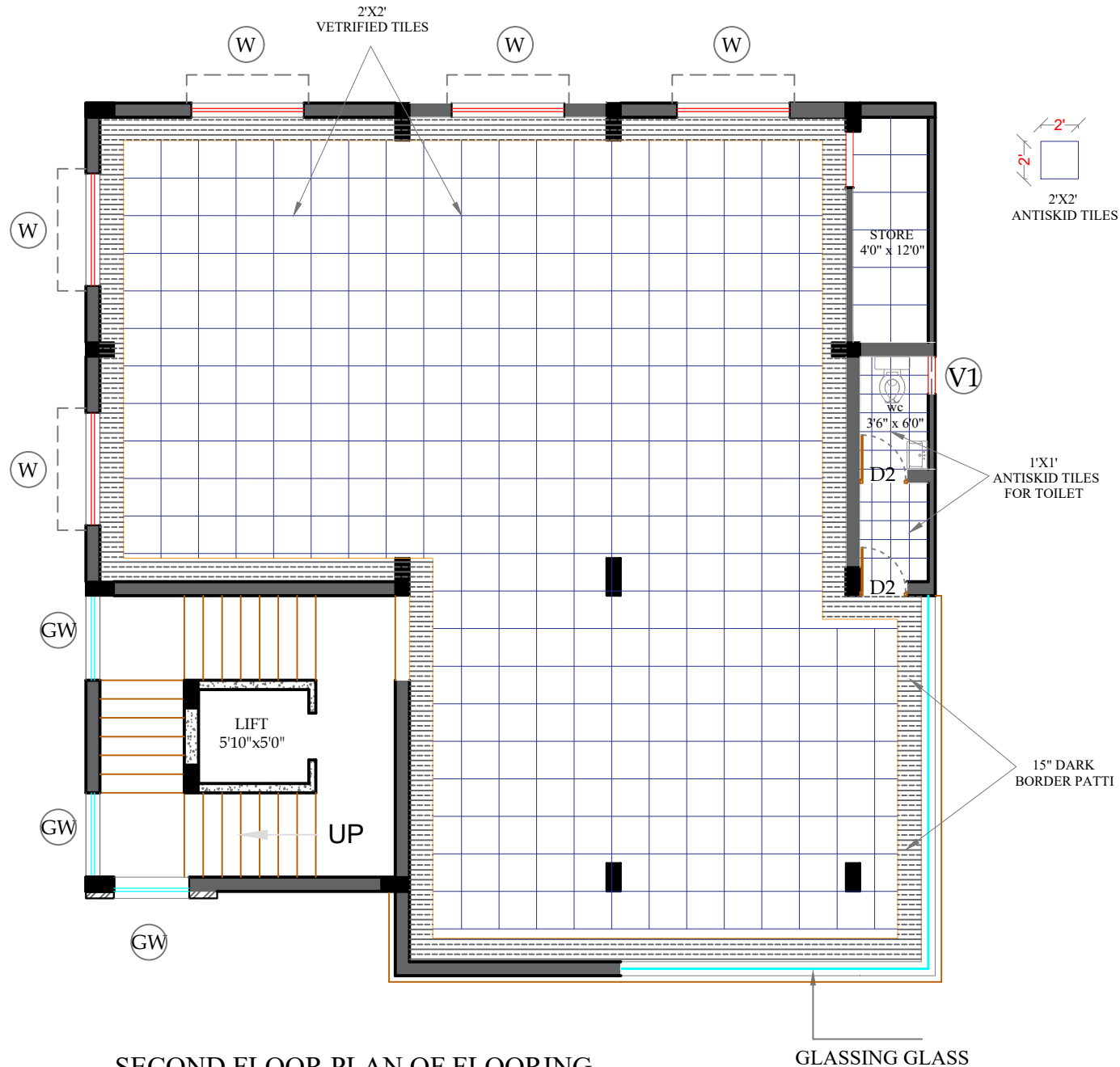




SECOND FLOOR PLAN OF FLOORING
